Entry Requirements

Employers can set their own entry requirements; however, learners must be of the right calibre and committed to achieve all components of their apprenticeships.

About the Role

Warehouse Operatives work in a variety of warehouse environments. Work activities include taking deliveries, checking for damaged/missing items, storing goods, moving stock by various methods, picking/packing orders, loading goods for dispatch, maintaining stock records and documentation, and cleaning. They are required to safely use a range of equipment, machinery and vehicles, as relevant to their role and setting. This could include mechanical racking systems, materials handling equipment (MHE) or fork lift trucks.

What Apprentices need to learn

Apprentices need to complete 20% off-the-job training during the on-programme phase of their apprenticeship. Specific rules govern this, and it must take place in the apprentice's contracted hours. Apprentices will learn the following skills:

Skills:

- Operate and handle equipment safely and efficiently
- Comply with appropriate rules, regulations and processes for safely and efficiently moving, handling, packing and unpacking
- Safely move and handle objects
- Safely and efficiently load and unload
- Select, prepare and use packaging materials
- Use correct equipment and procedures
- Work effectively in a warehousing team
- Use IT applications and other relevant technology and systems

End Point Assessment (EPA): how apprentices achieve their qualification

Apprentices on an Apprenticeship Standard are required to complete an End Point Assessment (EPA) to achieve their qualification. The end point assessment is designed to assess the knowledge, skills and behaviours gained are sufficient to be awarded the Standard. These will be assessed by a practical assessment and knowledge and behaviour test.

Before you can book end point assessment, Lakes College and the employer will sign off that the apprentice will be ready for EPA by a gateway assessment. Apprentices without Level 1 English and maths will need to achieve this level and take the test for Level 2 English and maths prior to taking the end point assessment.
